All bids must be accompanied by a bid security of the respective amount indicated above, issued in Kenya shillings or a freely convertible currency in the form of bank or insurance guarantee, and valid for a period of one hundred and twenty (120) days from the date of tender opening..

There shall be a pre-bid meeting for all the prospective bidders on **Thursday 20th May 2010**, at KWS Headquarters, Vet boardroom starting at 10.00am

The completed bids in plain sealed envelope marked with tender reference number and tender name, shall be deposited into the **Tender Box** located at the entrance of **Simba court, KWS Headquarters, Langa'ta Road P.O. Box 40241, Nairobi** on or before **12:000 Noon Thursday 3rd June 2010**.

The tenders shall be opened immediately thereafter in the presence of bidders representatives who wish to attend at KWS Board Room.
