SECTION II: PREQUALIFICATION INSTRUCTIONS

1. Introduction

- 1.1 Kenya Wildlife Service would like to invite interested candidates who qualify by meeting the set criteria as provided, to supply and deliver goods or provide services to various parks and stations countrywide department.

2. Pre-qualification Objective

- 2.1 The main objective is to have a database of approved suppliers to supply and deliver assorted items and provide services under relevant tenders/quotations to the Director General as and when required for the period ending 30th June 2022.

3. Experience

- 3.1 Prospective suppliers and contractors must have carried out successful supply and delivery of similar items/services to government institutions of similar size and complexity. Potential suppliers/contractors must demonstrate the willingness and commitment to meet the prequalification criteria.

4. Pre-qualification document

- 4.1 This document includes questionnaire forms and documents required from prospective suppliers. In order to be considered for pre-qualification/registration, prospective suppliers must submit all the information herein requested.

5. Submission of pre-qualification documents

7.2 Kenya Wildlife Service has the right to invite Open Tenders for goods, works or services in any of the categories as and when required in line with the Public Procurement and Disposal Act and the regulations.

7.3 KWS reserves the right to authenticate information provided herein without reverting to the participant.

7.4 In order to allow prospective tenderers reasonable time in which to take the amendment into account in preparing their tenders, KWS, at its discretion, may extend the deadline for submission of tenders.

8. Payments

8.1 All local purchase orders shall be on credit of a minimum of thirty (30) days or as may be stipulated in the contract agreement.

9. Pre-qualification data forms

9.1 The attached questionnaire forms are to be fully completed by the prospective suppliers/contractors who wish to be pre-qualified for submission of tender for specific category.

9.2 The pre-qualified/registered application forms which are not filled out completely and submitted in the prescribed manner will not be considered. All the documents that form part of the proposal must be written in English and in ink.

10 Qualifications

10.1 It is understood and agreed that the pre-qualification/registration data on prospective bidders is to be used by Kenya Wildlife Service in determining, according to its sole judgement and discretion, the qualification of prospective bidders to perform in respect to the tender category as described by the client.

10.2 Prospective bidders must provide a detailed individual/company profile which must include;

- a) Copy of Business Registration Certificate / Trade license, as well as a copy of Tax Compliance Certificate.
- b) Physical addresses and contact details.

10.3 Prospective bidders will not be considered qualified unless in the judgement of Kenya Wildlife Service they possess capability, experience, qualified personnel available and suitability of equipment and net current assets or working capital sufficient to satisfactorily execute the contract for goods/services.

11. Essential criteria for pre-qualification/registered.

11.1 Experience: prospective bidders shall have experience in the supply of goods, services and allied items. The potential supplier/contractor should show competence, willingness and capacity to service the contract at short notice.

11.2 Personnel

The names and pertinent information and CVs of the key personnel for individual or group to execute the contract must be indicated in Form PQ3.

12.3 Financial position

The supplier's financial condition will be determined by the latest financial statement submitted with the prequalification documents as well as letters of reference from their bankers regarding supplier/contractor's credit position. Potential suppliers/contractors will be pre-qualified on the satisfactory information given.

13. Past performance

13.1 Past performance will be given due consideration in pre-qualifying bidders. Letter of reference and or copies of order/contracts from past customers should be included in the business questionnaire form

13.2 Statement

Application must include a sworn statement form in the business questionnaire form by the tenderer ensuring the accuracy of the information given.

14. Litigation history

The applicant should provide accurate information on any litigation or arbitration resulting from contracts completed or under its execution over the last two years. A consistent history of awards against the applicant or any partner of a joint venture may result in failure of the application.

15. Withdrawal of Prequalification

Should a condition arise between the time the firm is pre-qualified to bid and the bid opening date which in the opinion of the client/Kenya Wildlife Service could substantially change the performance and qualification of the bidder or his ability to perform such as but not limited to bankruptcy, change in ownership or new commitments, Kenya Wildlife Service reserves the right to reject the tender from such bidder even though he was initially pre-qualified.

15.1 The firm must have a fixed business premise and must be registered in Kenya, with certificate of registration incorporation/ memorandum and article of association, copies of which must be attached.

15.2 The firm must show proof that it has paid all its statutory obligations and have current tax compliance certificate which is mandatory.
